Championship Concept

New concept for organisation

- SCA takes over full organisation process of Swiss Championship
- no club is hosting
 - Swiss Cheer Open can still be organized by a club, we can only offer 10% of the catering as profit
- Therefore SCA organisation committee needs to be formed
 - if you are interested or know someone who is contact us at championships@swisscheer.ch
- Helper for championship per club
 - Proposal: 1 helper must be provided for every 10 members
 - 7 club members = 1 Helper
 - 46 club members = 5 Helpers



Education Concept SCA

Basic Coaches Course:

- → Create foundation for new Coaches
- → Create unity for experienced coaches
- → "Quality management"

How:

- → 2-day course (2x/year, at the beginning of the season & mid-season)
- Day 1: theoretical inputs on basic knowledge & implementation into practice; followed by written 20-minute exam (QS) at the end of the day
- Day 2: practical inputs in the gym (in small groups taking turns)



Education Concept SCA

Advanced Coaches Course:

offer platform to further deepen basic knowledge on various topics (independent of Level and Cheer/Performance Cheer)

How:

- → 1-day course (mid-season)
- Starting with general input on important topics (e. g. ethics) followed by each participant choosing 3 workshops they then follow throughout the day

Topics of the workshops:

- basic spotting techniques for tumbling (beginner-advanced)
- how to deal with injuries/taping techniques
- mental training
- sexual assault prevention



Education Concept ICU

Additional ICU Courses:

- → Rules Comprehension Course: Module B & C
- → Global Coaching Techniques: Module A
- → Coaching Skill Credentialing: Level 1 / Novice
- → Coaching Skill Credentialing: Level 2 / Intermediate
- → Coaching Skill Credentialing: Level 3 / Median
- → Coaching Skill Credentialing: Level 4 / Advanced
- → Coaching Skill Credentialing: Level 5 / Elite
- → Coaching Skill Credentialing: Level 6 / Premier
- → Coaching Skill Credentialing: Special Olympics

Education Concept - J+S




J+S (youth + sport) = largest sports promotion project in switzerland

- promoting healthy, sustainable and integrative sport in clubs
- → funded by the government (Baspo)
- → 1.30 CHF/person/hour (max 1.5h) but mandatory education needed (18+)
- → J+S courses that qualify for cheerleading/performance cheer: Gymnastik & Tanz, Turnen, Akrobatik

e. g. Team of 20 people practices 2x/week for 1.5h: 4 CHF/person/week = ~3000CHF/season





Education Concept - J+S

14-18 Coaches course

- → assistant coach programm (14-18 years)
- → salary of 5CHF per practice

14 cantons offer the program (AG, AR, BL, BS, BE, GR, LU, NW, SH, SZ, TI, ZG, ZH)

Data Protection Law

The new Data Protection Act will be instated on the 1st of September.

Most important changes: General transparency obligations, strengthening of the rights of data subjects by means of fines, data security is given a high priority, due diligence in the selection and control of providers



What needs to be done with information that is considered 'particularly sensitive personal data?

- Keeping a processing directory
 Explicit consent required
- written or spoken words or signs (e.g. ticking a box, the active selection of certain technical parameters or in the specific context a clear sign or movement)

Why is data protection important?

- **Reputation / Marketing Message** -
- Minimize the risk of fines, e.g. with:
 Incomplete information -

 - Not informing the persons concerned
 - Transfer of data to third countries without that adequate data protection is guaranteed

General Measures

There are also a few measures that always make sense - regardless of the specific data processing:

- Carry out regular updates of software and systems
- Sensitization and training of employees, coaches and board members
- Authorization management
- Password manager and/or two-factor authentication
- Set up backups correctly so that they cannot be infected with ransomware in the event of a cyber attack
- Encryption of particularly sensitive data during transmission

Background Check

A criminal record check is essential for a coach to ensure the safety and well-being of athletes under their guidance. The decision by the board to make this mandatory reflects our commitment to maintaining a secure environment for all athletes.

Important:

- every coach needs to have a background check
- the board of the club needs to prepare the application online
- we will send out a explanation how to do that as soon as possible
